1. All Ice Cream must be made on site,
2. Contestants may begin making their Ice Cream as early as noon on Sunday May 16th.
3. Contestants must provide all ingredients, utensils, and equipment for making his/her recipe. (Ice will be provided by the fair)
4. Electricity will be provided by the fair but the contestant must bring their own extension cords and/or power strips.
5. Judging will begin at 3PM
6. JUDGES' DECISION IS FINAL. Based on judging criteria below.
7. At 3:30PM. Or as soon as all entries have been judged and the scores tabulated, contest winners will be announced. Prizes will be mailed to the contestants at the same time as the rest of the premium checks.
8. Contestants may have only one entry per class.
9. Once the judging is over contestants can give away samples to fairgoers. (Cups and spoons will be provided by the fair)

JUDGING CRITERIA

The event will be blind judging. A volunteer will pick up your ice cream sample and take it to the judges. Each entry will be assigned a number and four samples cups. Do not write on the sample cups. In case of a tie a second sample may be requested. Volunteer qualified judges will sample each recipe and judge them on the following
